It was discussed and agreed to formally create a pavilion steering committee which would examine as many of the issues as possible to formulate recommendations to the PC. The size was agreed to be four members comprising Cllrs C Woodley, J Barsley, R Dafter and I McEwen. The Clerk would take part in the discussions and help with project management

Correspondence**TWBC**

A letter had been received from Mr J Kehoe regarding the way the Borough liaises with the PC on planning applications. When a Borough officer disagrees with a recommendation of the PC the PC is advised. The PC then can ask for the matter to be "called in" by a Borough Councillor. Issues arise as this takes time. There is no commitment by the Borough to hold off making a decision in that time. Therefore he proposes that for a trial period of 6 months no decision is taken by the Borough for at least 5 working days after the PC is advised of this disagreement. The PC took the view that this was a positive step forward and to be commended.

TWBC

A copy of the now adopted Local Development Framework had been distributed. The PC agreed to consider this for discussion at the next meeting.

Resident

The owner of a farm in Knowle Road has made an offer of assistance with an excavator to help clear Petteridge playing ground as and when required. The Clerk has spoken to the gentlemen to thank him for his offer and Cllr Woodley would do the same.

Other Matters as maybe previously notified**Brenchley War Memorial**

Consideration was given to the commissioning of bronze plaques to record the names on the Brenchley memorial. It was agreed that with the potential levels of expenditure on the pavilion the issue was inappropriate at the present time and would be reconsidered at a later date.
